#EatLocalMilton Contest Official Rules

Milton, ON Restaurant Contest - November 26, 2020 to January 31, 2021

General Overview

- \$4,000 in gift card value in total prizing.
- Participating restaurants posted on the Milton Chamber of Chamber website. These establishments are members of the Chamber.
- Contest period runs from Thursday, November 26, 2020 until midnight on January 31, 2021.
- Minimum purchase of \$15.00 (incl. hst) per receipt to qualify for contest.
- Customers of a participating restaurant can email a photo of a receipt (which
 must be clearly dated as being a minimum \$15 purchase made in the contest
 period) from a local, participating restaurant.
- The email for customer receipts is <u>contest@miltonchamber.ca</u>
- Each receipt submitted is considered a ballot.
- An early bird draw will be done the first week of January based on ballots received by December 31, 2020. Prize is a \$500 gift card*. (winner ballot not returned for final draws)
- Final draws will be made in early February 2021 based on ballots received during the contest period. Prizes are as follows: one (1) prize of a \$1,000 gift card; two (2) prizes of \$750 gift cards; and two (2) prizes of \$500 gift cards. Total prizing of \$4,000 in gift cards (including the early bird)
- *Prizes are a gift card for the restaurants matching the winning receipts. Gift cards must be used at that restaurant and are not redeemable for cash.

The Fine Print - the Official Rules

- Contest Overview: The Milton Chamber of Commerce (MCC) and Gordon Food Service (GFS) are sponsoring a contest for customers to support our local restaurants ("Contest"). This Contest is governed by these official rules ("Official Rules"). Prize winners will be selected under the criteria specified in these Official Rules. All interpretations of the Official Rules and decisions related to the Contest made by the MCC are final.
- 2. **Contest Period**: Contest purchase period commences at 12:01 AM ET on November 26, 2020 and ends at 11:59 PM ET on January 31, 2021. ("Contest Period"). All entries must be received by January 31, 2021 at 11:59 PM by electronic entry to contest@miltonchamber.ca No other entries will qualify.
- 3. **Eligibility**: The Contest is open to anyone making a minimum purchase of \$15.00 (incl. hst) at a participating restaurant (as listed on MCC website) who are 18 years or older at the time of entry during the Contest Period. MCC employees are not eligible to win.
- 4. **Purchases:** Any receipt from a participating restaurant during the Contest Period be entered to win. There is no minimum dollar amount of a purchase to participate. Multiple entries can be submitted by Participants, but each entry is restricted to one receipt per

- entry which must be separate and distinct purchases from their other entries submitted. The odds of winning depend on the number of completed entries.
- 5. Participation: By participating in this Contest, Participants: (1) agree to be bound by these Official Rues and by the interpretations of these Official Rules by MCC; and (2) agree to comply with all applicable federal, state and local laws, rules and regulations, and the Official Rules. By participating in this Contest, Participants also agree to indemnify, hold harmless and release MCC, and any entity involved in the creation, operation, or fulfillment of the Contest and their respective agents, employees, elected officials, officers, directors, successors and assigns from and against all claims, injuries, or damages arising out of or relating to participation in the Contest; the use, misuses, or redemption of the prizes; and for any claim, including claims based on defamation, publicity rights, invasion of privacy, copyright infringement, trademark infringement, or any other intellectual property related cause of action.
- 6. **To Enter:** participants must email their applicable receipt via <u>contest@miltonchamber.ca</u> and their first and last name, email address; and, if it is not clear on the receipt, the restaurant name at which they made their purchase during the Contest Period.
- 7. **Prizes:** There will one grand prize winner selected from the receipts submitted. The grand prize winner will be awarded a gift card in the amount of \$1,000. There will also be additional prizes of two (2) prizes of \$750 gift cards; and two (2) prizes of \$500 gift cards. The Early Bird is a \$500 gift card. The Early Bird ballot will not be put back in for the final draws. Gift cards will be for the restaurants that match the winning receipts for that applicable draw. Winners must comply with these Official Rules. The winners will be notified via contact information provided. Every attempt will be made to contact the winner. Winners who do not reply by February 15, 2021, will forfeit their prize. Winners may waive their right to receive prizes. Prizes are non-assignable and non-transferable. No substitutions allowed by Winners. Prizes are not redeemable for cash. Submission of an entry grants MCC the right, except where prohibited by law, to use the Participant's name, likeness, picture, address (city and province only), for promotional purposes in marketing or publicizing the Contest, without compensation.
- 8. **Selection and Notification:** The Winners will be selected from all the eligible entries on January 31, 2021 or, for Early Bird draw purposes by December 31, 2020. MCC reserves the right to select alternative Winners if any potential Winner fails to comply with these Official Rules.
- 9. **General Terms:** MCC is not responsible if the Contest cannot take place, or if any prize cannot be awarded due to events outside of the reasonable control of MCC. MCC reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Contest or any part of the Contest. Any violation of these official rules by a Winner will result in such Winner's disqualification as a Winner of the contest and all privileges as a Winner will be immediately terminated. There is no limit to the number of completed entries of receipts dated November 26, 2020 to January 31, 2021, submitted by Participants by January 31, 2021 at 11:59 PM, subject to the conditions contained in these Rules.
